Lieutenant Governor

The function of the <u>Lieutenant Governor</u> is to act as Governor if the Governor is removed from office or is unable to perform the duties of the office, to be the presiding officer of the Senate, to serve as acting Governor when the Governor is absent from the state, and to discharge other duties as prescribed by law.

The Lieutenant Governor serves by tradition as Chair of the Senate Rules Committee. The Lieutenant Governor is a member of the State Finance Committee, State Capitol Committee, the Washington Health Care Facilities Authority, the Washington Higher Education Facilities Authority, and the State Medal of Merit Committee.

LIEUTENANT GOVERNOR

The job of the Lieutenant Governor is to: serve as acting Governor when the Governor is absent from the state, or if the Governor is removed from office or is otherwise unable to perform the duties of the office; serve as presiding officer (President) of the Senate; to discharge other duties as prescribed by law; and manage a state agency.

Acting Governor

The Lieutenant Governor becomes the acting Governor whenever the Governor leaves the state or is otherwise unable to serve. In this capacity, the Lieutenant Governor needs to be prepared to assume all of the state's executive responsibilities at a moment's notice, particularly in response to an emergency.

President of the Senate

As President of the Senate, the Lieutenant Governor presides at the rostrum in the Senate chambers whenever the Senate is in session, where he leads the parliamentary discussion as legislation is being debated. If there is a dispute on the floor, or if there is a question on the procedural correctness or legality of a motion, the Lieutenant Governor makes a ruling on the matter.

The Lieutenant Governor also presides over all joint sessions of the Senate and House of Representatives, which notably occurs during the Governor's annual State of the State Address, the Chief Justice of the Supreme Court's State of the Judiciary Address, and other occasions such as when foreign dignitaries address the Legislature.

The Lieutenant Governor chairs the Senate Rules Committee, the 17-member committee that determines which legislation advances to the Senate Floor Calendar. The Lieutenant Governor is a voting member of the Senate Rules Committee.

Legislative Committee on Economic Development and International Relations (RCW 43.15.060)

The Lieutenant Governor by law chairs the Legislative Committee on Economic Development and International Relations (LCEDIR). This bicameral committee consists of 16 legislators, four from each caucus of the House and the Senate, plus the Lieutenant Governor as chair.

LCEDIR is authorized to study and review economic development issues with special emphasis on international trade, tourism, investment, and industrial development, and to assist the Legislature in developing a comprehensive and consistent economic development policy.

As chair of LCEDIR the Lieutenant Governor is the state's representative to the Washington State-British Columbia interparliamentary exchange group (RCW 44.04.420). The purpose of the group is to facilitate legislator-to-legislator communication between the two governments, in coordination with the province of British Columbia.

Throughout the year, the Lieutenant Governor meets with foreign dignitaries and officials on behalf of the State, including by participating in local cultural events hosted by foreign governments and community groups. Additionally, the Lieutenant Governor represents the State by leading trade and diplomatic missions to foreign countries, in partnership with the Departments of Agriculture and Commerce.


Office of the Lieutenant Governor

The Lieutenant Governor leads the Office of the Lieutenant Governor, a state agency that supports the Lieutenant Governor in carrying out his (or her) official duties and those assigned to the office by statute.

The Office of the Lieutenant Governor administers the Legislative Youth Advisory Council (RCW 43.15.095). The council consists of at least 22 youth aged 14-18, appointed to two-year terms by the Lieutenant Governor. The Office of the Lieutenant Governor schedules the council's meetings and monthly activities associated with carrying out the council's duties to advise the Legislature on matters of importance to youth in the state.

The Office of the Lieutenant Governor also assists Washingtonians navigate their state government by providing casework assistance and connection to their legislators and members of Congress, and other state agencies.
