#### **Commission Work Session**

Teri shared what happens next in the process. She said that the final salary schedule must be filed with the Secretary of State no later than the first Monday in June and automatically becomes law 90 days after the filing, unless overturned by a voter referendum. The salary schedule becomes effective on September 1st of both years if not overturned by a voter referendum.

Teri reminded Commissioners of the upcoming conference call scheduled for June 24<sup>th</sup> at 10:00 a.m. she said that she will send the call-in information later.

Ned asked Teri to give an update on the office's budget. Teri shared that she is still waiting to hear if she can legally move the office from the State's system. Liz stated that they needed a plan. Dick gave an overview what had been done to date. Greg suggested that a committee be formed to take a look at the budget. The following Commissioners volunteered to be on the budget committee:
