# Meeting Opening Statement and Approval of the April 24, 2013 Minutes

Michele Adams read the opening statement. Teri Wright explained there was a small change to correct a misspelled word on the April 24<sup>th</sup> Meeting Minutes. There was a motion by Justine Winnie to approve the minutes with the change. The motion was seconded by Erin John and carried with a unanimous voice vote.

## **Review Meeting Folder Items**

Teri went over the meeting folder contents, including new elected officials point factor evaluations, economic review update, two letters from Chief Justice Barbara Madsen, and a news article in which the commission was mentioned.

## Lisa Skriletz, Senior Classification Advisor, State Human Resources Office

Lisa Skriletz informed the commission that after reviewing the positions in the Executive Branch, most of the plateau levels had not changed since the last review in 2007. A

point factor evaluation was conducted for each position to determine the most appropriate placement within the structure. Positions were rated on knowledge and skills, mental demands, and accountability. The Lieutenant Governor and the State Treasurer were evaluated at a higher level plateau than previously evaluated. The position of Treasure was recommended to move from plateau 5 to plateau 6. The position of Lieutenant Governor was recommended to move from plateau 4 to plateau 5.

Additionally, Lisa explained the changes in the Point Factor Evaluation from plateaus A through G to plateau's 6 through 1 was made administratively by their office to streamline the evaluations.

## Candace Espeseth, Budget Manager, Office of Financial Management

Candace Espeseth explained the budget process and that it is not unusual for the Legislature to call a special session to set the budget. Most often when you hear about the budget it is referring to the general fund budget which is primarily funded by property taxes, business, and sales and use tax. These funds are used for all the services authorized in state law and are not related to transportation or capital budgets. Salaries are included in the general fund budget and some are negotiated with state labor groups.

#### Commission Work Session

Teri told the commission about her time with the delegation from Kenya. She learned a lot about the differences in our government and the Kenyan government. They were very interested to learn how things are done here in Washington. She spent one and a half days with the group and sent a complete 2013 Salary Setting Binder with them for them to possibly duplicate with Kenyan information.

Ned Lange moved to increase the salaries for the Judicial Branch by 2% in 2013 and 3% in 2014. The motion was seconded by Matthew Clark. A roll call vote was taken as follows:
